#### **RESPONSE:**

As part of the approval for work on designated creeks and rivers the Department of Fisheries will include the removal of existing causeways as a condition of consent to improve fish movement. For bridges this is not the case, however, unless the bridge is of high heritage value I would recommend demolition as the old bridge will still involve maintenance costs and safety issues. The truss bridge that has been left by Tamworth Regional Council at Bendemeer is an excellent example of this.
